Our Mission

The Accelerating Clinical Trials (ACT) Canada Consortium was established with CIHR funding and pan-Canadian participants to facilitate, optimize, and accelerate the conduct, implementation, and result translation from high-quality, high-impact randomized controlled trials to improve health in Canada and globally.

Since 2023, ACT has established a network of 34 research networks, 11 clinical trial units, and 20 community hospitals, facilitating collaboration across Canada. Additionally, our consortium committees and working groups include patient partners, biotechnology industry leaders, and research ethics review experts. We provide guidance and guidelines on various clinical trials processes, including contracts, regulatory processes, patient engagement, training, and knowledge mobilization to improve the Canadian clinical trials ecosystem.


